TERMS AND CONDITIONS - SCHOLARSHIP/FELLOWSHIPS/AWARDS

GENERAL TERMS AND CONDITIONS

Registration: You must maintain full-time enrolment and be actively engaged in full-time academic pursuits in your current program. An offer of Ryerson funding is not transferable to another program.

Withdrawal during a term in which a graduate student has received a Ryerson scholarship, fellowship or award will require repayment of this funding in an amount calculated based on the Ryerson University tuition refund policy, i.e. full repayment if withdrawal occurs before the final date to withdraw and be eligible for full refund of fees; 50% repayment if withdrawal occurs before the final date to withdraw and be eligible for 50% refund of fees; and no repayment required if withdrawal is after that date.

Scholarship/Fellowship Renewal: A scholarship/fellowship is only tenable for the period defined in the offer. If the offer states that it is eligible for renewal, then renewal is also contingent upon a minimum cumulative GPA of 3.67 with no failed grades and a “Clear” academic standing. Scholarships for students in one-year programs are not eligible for renewal.

If the offer states that it is eligible for renewal, then renewal is contingent upon your seeking external funding through all government programs for which you are eligible (e.g. OGS, NSERC, SSHRC, CIHR).

At the *Master’s* level, a one-year offer may be renewed for one or two terms. Under “exceptional” circumstances, you may apply to your Program Director for renewal for a third term. At the *Doctoral* level, offers are generally made for a three year period, based on achieving a 3.67 in each course and maintaining a “Clear” academic standing.

Employment: You may also accept research or graduate teaching assistantships, or other employment up to an average of 10 hours per week or 130 hours per term.

ADDITIONAL TERMS AND CONDITIONS

Ryerson Graduate Scholarship (RGS), Ryerson Graduate Fellowship (RGF)

You must maintain a cumulative GPA of 3.67 (or equivalent) in the last year of study prior to the commencement of the scholarship. If you accept/have accepted an external scholarship, you must forfeit/decline the RGS. Students with external scholarships are eligible to be considered for Ryerson Graduate Awards (RGA) through their program.

Ryerson Graduate Award (RGA)

The RGAs are awarded by your Program.

Rogers Fellowship

If you hold a \$20,000 Rogers Fellowship and are awarded an external scholarship or award that is administered by Ryerson and that is greater than \$5,000, you must accept the external scholarship in place of your Rogers Fellowship. You will then receive a Rogers Fellowship or Ryerson Graduate Award which will bring the total value to a minimum of \$20,000.

OGS (Ontario Graduate Scholarship) and OGSST (Ontario Graduate Scholarship in Science and Technology)

You must adhere to the Terms and Conditions set by the *Ministry of Training, Colleges and Universities* for acceptance of an OGS or OGSST. Remember, **YOU CANNOT HOLD AN OGS AWARD FOR ONLY ONE TERM**. You must repay the entire amount already paid to you if, during the first two terms of your OGS award, you fail to enrol and attend full-time, withdraw, change to part-time status, fail to complete a term, or complete your program after the first term of the award.

You may hold other awards that, together, may not exceed \$10,000, except for Rogers-OGS holders, who are limited to an additional \$5,000.

Ryerson International Student Scholarship

You must notify your program IMMEDIATELY if your immigration status changes.

DISBURSEMENT OF FUNDS

Your funds will be applied as a direct payment to your Ryerson fees account in three instalments during the first week of classes in September, January and May. You will NOT be charged late fees during these months if there is no outstanding balance after the transfer. However, if there is an outstanding balance, you are responsible for paying this by the end of the month, or late fees will be charged on the outstanding balance.

If there are any funds remaining in your account after tuition has been deducted, a refund cheque for the balance will automatically be sent to your mailing address on Ryerson's Student Administration System. Keep this address current. If your cheque goes missing, it takes up to two months to re-issue a missing cheque. We will make every effort to have the cheque at your address (within the GTA) before the end of the first month of classes in each term.
