1. BACKGROUND, TERMS OF REFERENCE, AND PURPOSE

The Ryerson Centre for Immigration and Settlement (RCIS) is a University-based Research Centre established in 2011 in accordance with Ryerson University's Senate Policy on Research Centres #144.

According to the Senate Policy, all research centres at Ryerson should enable strategic alliances between the University and other sectors, including both the extended public sector and private enterprise. They must also demonstrate administrative and academic accountability, academic integrity, sector responsiveness, and fiscal responsibility. A University-based Centre focuses on an area that is of broad-based interest and priority within the University. Faculty, staff and students are drawn from a range of Faculties, Departments and Schools to participate in the Centre's activities. A University-based Centre is required to:

- establish terms of reference;
- have a sustainable infrastructure, partially supported by the University, under the leadership of an Academic Director;
- establish an Advisory Committee with a membership reflective of the internal and external sectors' needs to provide guidance to the Centre;
- secure external funding for SRC and engage in outreach activities for the benefit of the University;
- provide annual reports to the Vice President, Research and Innovation;
- be subject to a periodic review every five years;

As a University-based Research Centre, the overall goal of RCIS is to advance policy-related research and scholarship in the areas of immigration and settlement studies, both nationally and internationally. Immigration and settlement studies holds a strong presence at Ryerson and has generated high-caliber research and teaching at the University. Ryerson University was one of the three founding members of CERIS - the Ontario Metropolis Centre. Planning for, and the creation of, RCIS took into account the following successes in the university:

 In 2004, Ryerson launched the interdisciplinary Graduate Program in Immigration and Settlement Studies (ISS). ISS is the first such program in Canada devoted to advanced study of immigration policy, services, and experiences. It is also the only

- graduate program in Canada that focuses exclusively on the consequences and opportunities arising from transnational human mobility.
- In 2009, Ryerson launched an interdisciplinary PhD program in Policy Studies. One
 of the three fields in which students can specialize is Immigration, Settlement, and
 Diaspora Policies.
- The Faculties of Arts and Community Services developed and were delivering a wide range of courses that expose students to both historical and contemporary issues of transnational migration.
- Through its Gateway for International Professionals program, The G. Raymond
 Chang School of Continuing Education had established Ryerson's leadership in
 helping newcomers bridge the gaps between the foreign credentials and experience
 they brought with them and rewarding careers in Canada.
- A range of other research centres already existed at Ryerson, including the Centre
 for the Study of Commercial Activity, the Diversity Institute, and the International
 Research Institute at Ted Rogers School of Management. The creation of RCIS
 would complement these centres, building upon expertise across faculties.

In the context of this university-wide institutional and intellectual infrastructure, RCIS aims to be a leader in the trans-disciplinary exploration of international migration, integration, and diaspora and refugee studies. The transformation of the Canadian society through immigration is experienced most deeply at the level of public life and work. Governments, community-based organizations, healthcare facilities, and businesses must all grapple with the new ethno-cultural realities of Canadian life. The significant challenges these stakeholders face include urban (re)development, labour market integration, and equitable access to health services, housing, and education. RCIS is committed to integrating theory with social practice. In addition to supporting research in these areas, RCIS' mission includes mentoring students and consolidating Ryerson's reputation as the pre-eminent site of knowledge mobilization and exchange with governments, community organizations, and academics.

To guide the centre's development and operation, a five-year strategic plan was formulated shortly after the inception of RCIS. The Plan was formulated with six objectives

and eight strategies (see Table 1), which aligned with Ryerson University's academic plan *Shaping Our Future: Academic Plan for 2008-2013*.

Since its inception, RCIS has organically grown into an important and well-recognized centre for policy-relevant scholarly research and dissemination in the areas of immigration and settlement. It has also developed strong relationships with various government bodies, community partners, and the immigration scholars beyond the walls of Ryerson. In accordance with its mandate and in fulfillment of its objectives, RCIS organized a variety of SRC activities and produced many types of educational products. These activities and products have facilitated capacity building, partnership development, outreach to the immigration and settlement community, and the enhancement of Ryerson's and RCIS's reputation. This report summarizes RCIS's wide range of activities and achievements in its first five years of operation.

2. MANAGEMENT STRUCTURE AND RCIS AFFILIATES

RCIS's governance and administrative structure was established in confirmation with *Senate Policy on Research Centres # 144*.

The Academic Director of RCIS manages the daily operations of the centre and provides leadership to meet RCIS's research objectives. In addition, the Academic Director is responsible for reaching out to government agencies and the larger community, in addition to the Ryerson faculty and students with SRC interests in immigration and settlement, to participate in RCIS activities and governance.

The inaugural Academic Director was Dr. Harald Bauder from 2011-2015. Dr. Bauder is a full-time faculty member in the Department of Geography and Environmental Studies. Dr. John Shields and Dr. Shuguang Wang, both also full-time faculty members at Ryerson University, were successively appointed as Interim Director of RCIS by the Vice President, Research and Innovation, for 2015-2016 and 2016-2017 respectively (see Table 2).

In recognition of their research contributions and excellence, Dr. Bauder received the "Konrad Adenauer Research Award" in November 2015 (awarded jointly by the Royal Society of Canada and the Alexander v. Humboldt Foundation) and the "Sarwan Sahota Ryerson Distinguished Scholar in 2016 (Ryerson University's highest honour award for outstanding contribution to knowledge or artistic creativity); Dr. Shields received the "2016 National Metropolis Researcher Award" and the "Dean's Excellence Award for Research Impact" in 2016.

The Director is assisted by a Program Coordinator selected from among the candidates in the PhD program in Policy Studies. The Coordinator not only provides administrative support to the Director but also receives training in various aspects of scholarly research and creative activities. The Advisory Committee consists of the RCIS Director, Vice President (Research and Innovation), five faculty members elected from the Faculty of Arts and the Faculty of Community Services, two student representatives (one from the Policy Studies PhD Program, one from the ISS Program), and stakeholder representation (see Table 4 for the current Advisory Committee membership; see Appendix 1 for the past Advisory Committee membership). Normally, the Advisory Committee meets at least once each academic year to provide feedback and advice to the Director on policy matters and provide operational assistance with regard to formation of ad hoc sub-committees, input in the strategic direction of RCIS, and advice on fundraising initiatives.

As a campus-wide community of immigration and settlement researchers, RCIS has grown into a network of 51 Affiliates. Faculty affiliation occurs through invitation and/or application, based on a record of research in the area of immigration and settlement studies, including international migration, integration, and diaspora and refugee studies. The Affiliates represent the Faculty of Arts, the Faculty of Community Services, the Faculty of Communication & Design, the Yeates School of Graduate Studies, and the Ted Rogers School of Management. The full list of current RCIS Affiliates, including their recent publications, can be found in Appendix 2.

3. SOURCES OF CORE FUNDING

RCIS requires stable core funding for the operation and administration of the centre. So far, most of funding has been provided by the Offices of the Provost, Dean of Arts, and Dean of Community Services RCIS was expected to gradually become financially self-sufficient after five years into operation (in 2016), but this has not been realized yet, which will be explained in Section 9 of this report. Table 5 presents the budgeted revenues and expenses formulated in the RCIS founding document. Table 6 shows the actual revenues and the variations between the budgeted and actual revenues.

4. APPLICATION FOR EXTERNAL GRANTS AND OTHER FUND RAISING ACTIVITIES

RCIS has been making concerted efforts in pursuit of external grants to support the operation of the centre and its SRC activities. Both the centre and individual affiliates have successfully competed for funding from the Social Sciences and Humanities Research Council of Canada (SSHRC) and acquired funding from other sources. The Office of the Dean of Arts has also assisted RCIS in developing the "Case of Support", which was presented to potential funders.

The largest grant that RCIS has won is a **SSHRC Partnership Development Grant**, with a total value of **\$153,600**. This 4-year (2013-2016) grant was awarded to support the RCIS-led project titled "Integration Trajectories of Immigrant Families". The principal investigator of this project is Harald Bauder; 15 RCIS faculty affiliates, and 7 highly-regarded community-based organizations (including OCASI, COSTI, the Wellesley Institute, Woodgreen Community Services, Scarborough Housing Help Centre, Toronto Workforce Innovation Group, and METRAC) and community researchers, are part of the research team. Upon application for this grant, the intention was to apply for the full \$2,500,000 awarded through the Partnership Development Grant.

Other RCIS-led successful applications include:

- Ontario Human Capital and Research Innovation Fund (2014-2015) for the project
 "Towards the Creation of a Sanctuary Province". PI: Charity-Ann Hannan. Funding amount: \$16,267
- Centre for Labour Management Relations Research Grant (2015-2016) for the project "The Human Service Workforce Survey: Exploring Workplace and Service Provision in a Time of Austerity." PI: John Shields. Funding amount: \$7,500.
- Ontario Human Capital Research and Innovation Fund (OHCRIF) (2016-2017),
 "Adapting to the Ontario labour market: A critical assessment of the role of family in the labour market integration of immigrants", PI: John Shields. Funding Amount: \$47,074.50.

RCIS has also partnered and collaborated with other institutions/individual researchers in application for Tri-Council funding. The most recent success is a 5-year **SSHRC Partnership Grant** of \$2.5 million (2016-2021). This grant is awarded to support a collaborative research project titled "Migration and Resilience in Urban Canada: Discovering Strengths and Building"

Capacity". The PI of the project is Valerie Preston of York University. RCIS affiliates John Shields and Sutama Ghosh are co-applicants, and Harald Bauder is a collaborator. RCIS serves as the Hub of the Toronto Research Network, for which RCIS will receive funding transfers from this grant.

Among other successful RCIS collaborations are:

- SSHRC Partnership Grant: "Rights for Children and Youth Partnership". PI: Henry Parada of Ryerson University, also a RCIS affiliate. RCIS is the Co-applicant on this project. Funding amount: \$2.5 million for 5 years (2016 2021).
- SSHRC Partnership Development Grant: "Austerity and Its Alternatives". PI: Stephen McBride of McMaster University. John Shields of RCIS is a Collaborator. Funding amount: \$199,700 for 4 years (2016 – 2019).
- SSHRC Partnership Development Grant: "Policy Engagement at Multiple Levels of Governance: A Case Study of the Living Wage and Minimum Wage Policy." PI: Bryan Evans of Ryerson University. John Shields and Harald Bauder are coapplicants. Funding amount: \$170,900 (2014-2017).

RCIS was also successful in winning a SSHRC Connections Grant in 2013 to support the Ryerson conference "Immigration and Settlement: Precarious Futures". (PI: Harald Bauder; total amount: \$49,170. In addition, the following external funding application is currently pending:

Immigrant Families Adapting to the Ontario Labour Market through Postsecondary
 Training and Education, Ontario Human Capital Research and Innovation Fund. (PI: John Shields, \$47,184)

RCIS will continue developing and expanding its fund-raising strategy towards long-term sustainability of the centre, and cultivating relationships with foundations and individuals.

5. KNOWLEDGE MOBILIZATION

Knowledge mobilization through scholarly research and creative activities (SRC) is a core mission of RCIS. This has taken different forms and has taken place at different scales, in order to share information, exchange ideas, and disseminate research results. It includes research presentations, seminars, conferences, and publications.

Brownbag Presentation Series, Seminars, and Roundtable Discussions

The **Brownbag Presentation Series**, which started in 2012, cater mainly to RCIS Affiliates and graduate students in the ISS and Policy Studies PhD programs. The purpose of the Brownbag Presentations is to build synergies and research capacity across campus, and inform Affiliates and students about research expertise and interests available across campus. **Seminars**, **Roundtable Discussions**, **Lunch-and-Learn**, **and Meet-and-Greet** were also organized many times. They were widely attended by the immigration and settlement community, and received various media exposure. They were supported by wide-ranging collaborations, including with the Canadian Race Relations Foundation, the Canadian Civil Liberties Association, the CAW-Sam Gindin Chair in Social Justice and Democracy, CERIS – The Ontario Metropolis Centre, the Network on Age and Generation in Migration Context, the Ontario Council of Agencies Serving Immigrants (OCASI), and Ryerson's Student Union.

Conferences

In 2010, the then Working Group of RCIS organized an international conference, titled "Migration and the Global City", to announce the establishment of RCIS. This conference was intended to be the inaugural event of a regular RCIS conference series. It attracted 233 registration, with some from 10 countries outside of Canada. The participants presented research findings at 30 concurrent sessions and roundtables, plus 3 poster sessions.

The second RCIS conference was held in May of 2013, with the theme of "Immigration and Settlement: Precarious Futures?" This 3-day conference featured more than 80 panel sessions, 3 keynotes, a graduate student workshop, fieldtrips, a film night and musical performances, and a range of networking activities. It was attended by nearly 300 registered delegates from 5

continents. The keynotes were open to the public, which drew additional attendees and media attention.

RCIS co-organized and co-sponsored a number of other national and international conferences, as listed below:

 RCIS co-organized the conference (October 25-26, 2012)
- "Human Trafficking: What's Going On?" **RCIS co-sponsored opening panel** (November 30, 2012)
- Canadian Association for Refugee and Forced Migration Studies (CARFMS) 8th Annual Conference: Advancing Protection and Fostering Belonging in a Global Era of the Criminalization of Migration. RCIS co-hosted this event with the Dept. of Criminology (May 13-15, 2015)
- Policy Studies Conference "Policy Research in Times of Austerity and Uncertainty."
 RCIS co-sponsored keynote speaker Daniel Hiebert (May 9, 2013)

Publications and Book Projects

RCIS and its affiliates have contributed significant publications to the immigration and settlement field. The details of the publications are listed in Appendix 2. Most of these publications are peer-reviewed articles in well-known international journals; some are book chapters, discussion papers and reports. Co-authorship indicates a high level of collaboration between researchers within and beyond the Ryerson community and with graduate students. Among the most celebrated are two edited volumes: *Immigration and Settlement: Challenges, Experiences, and Opportunities*, and *Immigrant Experiences in North America: Understanding Settlement and Integration*.

Immigration and Settlement: Challenges, Experiences, and Opportunities was edited by RCIS' inaugural Academic Director – Harald Bauder, and was published by Canadian Scholars' Press in 2012. This volume draws on a selection of papers that were presented at the "International Migration and the Global City Conference" held in Ryerson University in 2010. Through the use of international and Canadian perspectives, this book examines the contemporary challenges, experiences, and opportunities of immigration and settlement in global, Canadian, and the Toronto contexts. In 17 comprehensive chapters, this 311-page book

approaches immigration and settlement from various thematic angles, including rights, state, and citizenship; immigrants as labour; communities and identities; housing and residential contexts; and emerging opportunities. It was adopted as a textbook in a required course in the ISS Program.

Immigrant Experiences in North America: Understanding Settlement and Integration was coedited by Harald Bauder and John Shields (RCIS' Interim Director) and was published also by Canadian Scholars' Press in 2015. With essays by an interdisciplinary team of American and Canadian scholars, this volume explores major themes such as immigration policy; labour markets and the economy; gender; demographic and settlement patterns; health, well-being, and food security; education; and media. Written as a textbook, each chapter includes instructive case examples, recommended further readings, links to web-based resources, and questions for critical thought. Fourteen of the contributing authors are Ryerson faculty members and RCIS affiliates and four are Ryerson graduate students or recent graduates. This volume has also been used as a graduate course text in the ISS program at Ryerson and has been adopted for courses at other universities.

In September of 2013, RCIS successfully launched the open-access RCIS Working Paper Series. So far, 33 Working Papers have been added to the open-access depository (see Appendix 3). These Working Papers present scholarly research in all disciplines on issues related to immigration and settlement. The purpose of the series is to stimulate discussion and collect feedback. Many of these papers were subsequently revised, expanded, and submitted to academic journals for publication. In addition, RCIS has launched a series of Research Briefs, which build upon RCIS research and knowledge translation activities. A total of six Research Briefs have been published to date.

6. STUDENT ENGAGEMENT AND TRAINING

Engaging students in SRC activities and providing training opportunities to them is another strategic objective of RCIS (see Objective 2, Strategy 4 in Table 1).

SRC activities of RCIS complement the educational activities of the MA Program in Immigration and Settlement Studies (ISS). Belonging to the same field of immigration and settlement studies, RCIS and ISS are in an ideal position to integrate research and education. Furthermore, the PhD Program in Policy Studies offers a field of specialization in Immigration, Settlement and Diaspora Policies. RCIS has been playing an important mentoring role in that field of specialization. RCIS has also endeavored to provide research assistantship and internship/placement opportunities through externally funded research projects and Ryerson's internal Work Study program. In addition to the three RCIS Program Coordinators (see Table 3), nine graduate students have been employed as research assistants through the *Integration Trajectories of Immigrant Families* project, and four students have been employed through the Ryerson Work Study Program (see Table 7). Ten Ryerson graduate students and research assistants have contributed to RCIS Working Papers and are listed as first authors or co-authors. Student volunteers have also been involved in event organization and activity planning. Such participation helped to connect students to researchers within and beyond the Ryerson community.

7. PARTNERSHIP AND COLLABORATION

Also in accordance with Ryerson Senate Policy #144, RCIS strives to enable strategic alliances between the University and other sectors, including both the extended public sector and private enterprise. Partnerships and collaborations have been developed for the purpose of creating an infrastructure for research and outreach, seeking research funding, and knowledge mobilization.

 (Paris 7) and Ryerson University RCIS affiliates and Director have been meeting and
 working on collaboration between scholars and graduate students at our institutions
 in the area of health and immigration research. This includes possible faculty and
 student exchanges.
- RCIS in partnership with the Turkish Society of Canada, the Ryerson Immigration and Settlement Studies Masters Program and the Ryerson Department of Sociology planned and hosted an event on May 15, 2016, a Career & Networking Day for immigrants of Turkish origin. It was a very successful event with some 20 information exchange tables, 5 panelists, 55 exchange table participants and an audience in excess of 200.
- Migration Policy Group: RCIS is the Canadian scientific partner updating the Migrant Policy Index (MIPEX), comparing immigration and integration policies internationally.
- Global Diversity Exchange (GDX): Since the inception of GDX in 2014, RCIS and GDX have collaborated on numerous projects and events, including the launch of the 2015 MIPEX scores for Canada and a number of open community presentations.

Internally, RCIS partnered with the PhD Program in Policy Studies to create the "2012 Summer Fellowship". Joan Andrew, the former Deputy Minister of Citizenship and Immigration (MCI) in Ontario from 2005 to 2009 and now a RCIS affiliate and past Public Servant in Residence in the Department of Politics and Public Administration, has facilitated ongoing

discussions to include MCI in this partnership. The selected fellow, Charity Hannan (PhD candidate in the Policy Studies Program) conducted a policy-relevant research project in consultation with the RCIS research team and the Immigration Policy Branch of MCI, and produced a RCIS Working Paper (See Appendix 3).

In keeping with policy relevance of the research and activities associated with RCIS, the centre is actively engaged with government bodies on a regular basis. In particular, the Academic Director of RCIS is an active member of two recently established government research bodies: one at the federal level of government, and the other with the Province of Ontario.

The federal body is the "Research Partnership Table", chaired by the Research and Evaluations Branch of Immigration, Refugees and Citizenship Canada (IRCC) and established in 2015. Members of this group are directors of research centres and networks from different provinces. They meet once a year in Ottawa (and engage in regular conference calls), where officials of IRCC brief the members on latest immigration policy changes and research priorities, and members exchange with each other research activities at their respective centres/networks.

The provincial body is "The Syrian Refugee Resettlement Secretariat's Academic Advisory Group, Syrian Refugee Resettlement Secretariat, Cabinet Office, Government of Ontario, established in 2016. In consultation with RCIS and other academics, the group is engaged in evidence-based examination of Syrian refugee settlement in Ontario. They are developing measures, including longitudinal based ones, of settlement to identify the progress of this refugee group.

8. REPUTATION BUILDING

Among RCIS's other activities is developing a strategy and infrastructure for effective communication. RCIS has worked closely with Ryerson's Media Relations office for the advertisement of its events and activities. Ryerson's Marketing and Production team developed a RCIS Wordmark and designed a promotional brochure, which RCIS has distributed widely. RCIS hired media consultants Bradley Lee and Isabella Tartar to attract media (including social media) coverage to the 2013 RCIS Conference. In addition, RCIS was able to receive significant media attention, including in *The Globe and Mail, The Toronto Star, The Montreal Gazette*, *PostMedia News*, *University Affairs*, *The Telegraph* (*UK*), *Baden-Württemberg* (*Germany*), and *OMNI News*. The RCIS Academic Director and affiliates (Harald Bauder and Myer Siemiatycki, for example) frequently accepted interviews by different news media to communicate research findings and provide commentaries on latest immigration-related issues and society concerns. RCIS's exposure in mainstream media and the active participation in social media have enhanced the reputation of RCIS and Ryerson University. See Appendix 4 for a detailed list of media coverage.

9. CHALLENGES

Despite RCIS' success in meeting the various objectives stated in its academic plan and the expectations stipulated in the Senate Policy on Research Centres (#144), RCIS has been facing two challenges that need to be addressed with support from the University: self-sufficiency in core funding and the establishment of an endowed Chair in Immigration and Settlement; and adequacy in office space for providing a productive research and learning environment.

Fund Raising and the establishment of an endowed Chair

As mentioned in Section 3 of this report, RCIS was expected to gradually become financially self-sufficient after five years into operation (i.e., starting in 2016). This includes core funding for the centre's administration (Academic Director's release and Program Coordinator's stipend) and operation. While RCIS has been successful in raising research funds through grant application and collaboration with research partners and Affiliates, these funds usually do not allow for overhead cost for the administration and operation of the centre. For example, the SSHRC Partnership Development Grant cannot be used for operating expenses to cover the Director's release time and the coordinator's stipend.

The RCIS founding document passed by Ryerson Senate in 2011 lists as the first "Activity" to "Establish an endowed Research Chair in Immigration and Settlement". This activity has not yet been pursued, as it requires the involvement of the Offices of the VP Research and Innovation and VP University Advancement. RCIS has established strong relationships with community partners and potential funders; however, it is a university requirement that potential significant donors be approached by the Office of VP University Advancement.

The budget of RCIS's founding document states that the responsibility to raise funds from other sources "requires broader discussion between the Deans and VPRI and the Provost concerning the distribution of grant overheads; any shortfall will be funded by the Deans of Arts and Community Services in the same proportion as the distribution of the overheads." RCIS requests that the Offices of the Provost and the Deans of Arts and Community Services will continue to cover the shortfalls in core funding until RCIS becomes fully financially self-sufficient. RCIS also proposes that the Offices of VPRI and the Deans of Arts and Community Services will reconsider the current model of overhead distribution and allow

RCIS to retain a higher portion from the external grants that include overhead costs, while collaborating more closely on efforts to attract major donations and gifts.

Ryerson received a \$1.75-million gift from RBC for the "RBC Immigrant, Diversity and Inclusion Project". The purpose of the gift is to support action-oriented research for 7 years (2014-2021) into the economic and social issues facing immigrants. RCIS is situated in a central position at Ryerson with unique strength for this type of research. While 20 RCIS Affiliates were successful in winning funding through competitions, RCIS does not receive any funding through this project. In the first year of the project, RCIS and Diversity Institute each had a representative who chaired one of the adjudication committees. The committees are now chaired by Associate Deans. It is fitting that RCIS receives some funds from this project to help cover part of its operating costs.

Space

Since its inception, RCIS has been temporarily housed in a regular office on the 6th floor of Jorgenson Hall. Although this space has enabled RCIS to sustain its operations, it was intended to be a temporary solution, as the initial founding agreement allowed for two faculty offices to be assigned to RCIS. Currently, the space provided is too small and too tight to provide a productive research and learning environment. Larger and more suitable office spaces are needed to accommodate research assistants, visiting scholars, and external Affiliates and to foster stimulating interactions. Since January 2013, the RCIS office has also been used by the ISS Placement Officer. While shared RCIS and ISS space is highly desirable, as it facilitates close coordination between research and education, more space should be made available. In the next phase of RCIS' growth, centrally-located, permanent space is needed and to be shared with ISS and Policy Studies students and staff, to create an effective research and learning environment and a stronger sense of community and innovation.
