Dr Alka Kumar's interests and work span across disciplinary borders, from the arts and humanities to the social sciences. After a meaningful first career as an educator and Associate Professor in English at the University of Delhi, in India, she is currently exploring migration and economic integration related issues through a doctoral program in Peace and Conflict Studies at University of Manitoba. Alka lives in Toronto now and has a part time research position with CERC at Ryerson University.

Describing herself as a researcher-practitioner, Alka has worked with new Canadians in a service provision role, developing and delivering programs, supporting individuals through career transition counseling, employment pathways planning, and skills training. She views `lived experience' and `practitioner positionality' as critical lenses to better understand economic and social inclusion challenges arising from migration, seeing them also as important tools for solution-building. In her role as Research and Capacity Director for a women-led charitable national initiative called The Shoe Project, (See http://www.theshoeproject.online/), she currently manages the research portfolio while seeking funding and other opportunities to expand the reach of this program.

Additionally, Alka teaches Professional and e-Communication, and Business Writing in a Finance Bridging Program at Skills for Change. As a member of the York Region Community Partnership Council, she is part of a Local Immigration Partnership team that is developing policy driven initiatives to enhance social and economic integration for newcomers in the York Region.
