Seed Awards

To support entrepreneurial and innovative ideas developed by engineering students enrolled in the Optional Specialization in Engineering Innovation and Entrepreneurship (OSEIE).

Eligibility and Application Process

Applicants must meet the following criteria:

- Be registered as a full-time undergraduate student in one of the engineering programs and also be enrolled in the OSEIE within the Faculty of Engineering and Architectural Science
- Have achieved a minimum CGPA of 3.0
- Must not have won the award previously
- Application letter/ Written statement (up to 500 words) summarizing the applicant's achievements on innovation and creativity as reflected in a course project on venture development arising from a course or courses as part of the OSEIE curriculum.

Criteria for Selection

Criteria	Weighting
Application Letter/ Written statement	100%

Adjudication

The selection committee will be composed of at least three representatives from the Faculty of Engineering and Architectural Science. They will review the application information and prepare a ranked list of qualified Award recipients. They will make the final selection of the recipient based on the weighted criteria.

If in the opinion of the selection committee that no candidates meet the outlined criteria, the award shall not be given to any applicant that year.
