1. Foreign Market Entry and Merger Policy with Economies of Scale (Job Market Paper), with Frank Stähler and Halis Murat Yildiz

This paper scrutinizes the entry of a foreign firm into a domestic market where the firm can enter by exporting, greenfield investment, or the acquisition of one of the two or both domestic firms. We observe that acquisitions are more likely with large economies of scale, and our model shows that this is also the endogenous outcome of merger policies. If economies of scale are not too large, the foreign firm does not always want to monopolize the market. If economies of scale are large, a single acquisition is the preferred market structure of the domestic country. However, merger policies cannot always prompt the domestic country's preferred market structure. We also show that they can be excessive as monopolization may maximize aggregate welfare if the economies of scale are substantial.
