

2022-2023 Ted Rogers MBA Black Graduate Leadership Awards

The Ted Rogers MBA Black Graduate Leadership awards are available to domestic full-time or flex full-time (3-5 course credits per semester) Master of Business Administration applicants accepted into graduate studies. These candidates would be pursuing their studies at Ted Rogers School of Management during the 2022-2023 academic year and self-identify as Black.

This award seeks to address the historical inequities in access to graduate education in Canada experienced by Black students and the underrepresentation of Black students within MBA programs.

The criteria for the awards are based on demonstrated leadership, community involvement and financial need.

Each student will receive an award of \$10,000.

Up to three awards will be provided annually.

WHO CAN APPLY?

- Candidates who are Canadian citizens, landed immigrants/permanent residents or protected persons who have been issued a Protected Persons Status Document (PPSD) and have been accepted to the Ted Rogers MBA Full-Time or Flex Full-Time MBA Program.
- Candidates who self-identify as Black.

TO APPLY

- Provide a 500-word statement outlining leadership and community involvement, budget form demonstrating financial need (included below), and declaration.
- Scan and email the form to mba@ryerson.ca using the subject line Ted Rogers MBA Black Graduate Leadership Award by the February 18th, 2022 first consideration date. Award applications will be reviewed on an ongoing basis past this deadline date based on funding availability.
