



# Pre-Placement Requirement Clearance Information Midwifery Education Programs

In partnership with Synergy Gateway Inc.

Toronto Metropolitan University has partnered with Synergy Gateway Inc. to provide support and clearance for pre-placement requirements. To have your documents validated you will be required to book an **Electronic Requirements Verification (ERV)** appointment through **Verified**, a proprietary platform that is used by students across Ontario for the purpose of digitally collecting placement requirements and documentation for verification. Log in details to <u>Verified</u> will be sent to your school email account once the system is up and running for our programs.

### YOUR ESPC APPOINTMENT

Be sure to review the list of pre-placement requirements below and have a plan when and how you will be completing them. It is important to remember that some requirements may take an extended time to complete.

Once your access is activated, book an ERV appointment through your *Verified* account. For help on how to navigate *Verified*, please log in and go to Important Forms. There you will find user guides to assist you with the process.

You are encouraged to *book* your appointment early, even if you do not have all documentation in place. Do not wait until a week or two before the deadline to book your appointment; appointment times will fill.

Ensure all your pre-placement documents are uploaded to your account by 9:00 AM (EST) on the day of your ESPC appointment. You do not need to be "present" on the day of your appointment – this is the date that Synergy Gateway retrieves your documents for review.

To avoid paying additional appointment fees, ensure all your documentation has been uploaded *before* 9 am (EST) of your ERV appointment date. If documents are outstanding at this time, you will not be cleared for placement. If documentation is missing or a requirement is not complete, you will need to book a follow-up appointment for an additional fee.





You will receive a Pre-Placement Completion Certificate (stamped document) once your documents have been reviewed. *Keep this for your records*.

If you need to cancel an appointment, ensure you cancel **at least 24 hours** prior to your appointment, or you will be charged for a missed appointment.

#### \*\* Important Note\*\*

Please ensure your documents are valid until the end of your placement period. Students with requirements expiring during the placement period must renew (before expiry) and provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for placement. This will require another ERV appointment at FULL service fees. To avoid multiple appointment fees, we suggest you update all expiring documents in one appointment.





## PRE-PLACEMENT REQUIREMENTS CHECKLIST - YEAR 1 STUDENTS MEDICAL REQUIREMENTS \* Students with certifications/requirements expiring during the placement period must renew (before expiry) and COMPLETED provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for placement. This will require another ERV appointment and there will be a charge for this appointment. WITH **DOCUMENTA** TION Health Screening Requirements form completed by an HCP - Please have your HCP complete your school immunization form. Along with this form, you must submit blood work results and vaccination records as proof. The form alone will not be accepted. Tetanus/Diphtheria Documentation of a primary series or adult catch-up series is required. Students must provide proof of tetanus and diphtheria-containing vaccine (TDaP or TDaP-IPV) received within the last 10 years and must be valid for the entire academic year. Health provider's signature required. **Pertussis** Documented proof of a pertussis booster given after the age of 18 or older is required AND health provider's signature on blood test results (public health serology blood work) indicating titres are at the level demonstrating immunity. If this information is no longer available, repeat the vaccination. Public health serology blood work) indicate titres are at the level demonstrating immunity. Polio Documentation of a primary series or adult catch-up series is required Measles, Mumps, Rubella (MMR) Documented proof of two vaccinations or blood work results showing immunity. You must upload the actual serology report showing immunity if you do not have proof of two vaccinations. **COVID-19 Vaccination Receipts** Documented proof of double vaccination status. - Proof of both vaccinations must be uploaded. This means dose 1 and 2. Only vaccines approved by Health Canada, external link, opens in new window will be accepted. **Hepatitis B Surface Antibody Blood work** Mandatory. You must submit proof of Hepatitis B Surface Antibody blood test results and proof of vaccination. **Hepatitis B Vaccinations –** Proof of primary series of at least 2 vaccinations is required. By health care provider (HCP) documentation or by lab results signed by HCP. If your serology results show you are not immune, then a second series and new blood work results will be required. To obtain a conditional clearance you will need to show proof that this has been started. Tuberculosis (Mantoux) - 2 Step TB Skin Test (+ 1-Step Test if required) Documented proof of a 2-step TB Skin Test (TST). If the 2-Step TST was completed more than 12 months ago, a current 1-Step TST is required. A medical follow-up with a chest x-ray is required if a person has EVER had documented positive TB Skin Test. Chest x-rays are good for 2 years, and you must include the chest x-ray report. NON-MEDICAL REQUIREMENTS \* Students with certifications/requirements expiring during the placement period must renew (before expiry) and provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for placement. This will require another ESPC appointment and there will be a charge for this appointment.

A medical follow-up with a chest x-ray is required if a person has EVER had a documented positive TB Skin Test. Chest x-rays are good for two years, and you must include the chest x-ray report with providers interpretation.		
Conditional Pass Requirements Please check your instructions from your previous clearance and ensure if you have been given a conditional clearance you update any new information required		
NON-MEDICAL REQUIREMENTS  * Students with certifications/requirements expiring during the placement period must renew (before expiry) and provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for placement. This will require another ESPC appointment and there will be a charge for this appointment.
