


Update from University Planning

Provincial Context: Budget

- Ontario budget for 2022-23, *Ontario's Plan to Build*, focused on infrastructure and managing inflation
- Fall Economic Statement projects \$12.9B deficit for 2022-23
- 2023-24 Provincial budget anticipated in Spring; significant investments in post-secondary not expected

Provincial Context: Financial Accountability

- Ministry has announced new Financial Accountability Framework to begin April 2023
- Universities are required to report annually on 8 financial indicators, with actions required if indicator values fall below a threshold


Domestic Enrolments

- We decreased the total number of domestic undergraduate students this year to return to our enrolment corridor.
- We are holding the number of new first year domestic students relatively constant in order to maintain current domestic enrolment levels.
- While we saw a dip in applications this year, Toronto Metropolitan University remains competitive and we project we will meet our domestic intake targets.

International Enrolments


- International intake remains volatile with the continuation of federal government visa processing issues and COVID restrictions in many countries.
- TMU's enrolment plan is to continue to increase international enrolment to meet our target of 15% international undergraduates.
- We are looking to expand international Fall intake as much as possible in this environment and expand the pilot Winter intake as much as possible.

Government Tuition Fee Policy

- Continuation of tuition fee freeze for domestic students within province is expected through 2023-24.
- In 2019-20, a decrease of 10% to domestic tuition fees in comparison to 2018-19 levels was implemented. Tuition for Ontario students has remained frozen ever since with no adjustments for inflation as per government's policy.
- Impact of reductions and freeze will echo into future years, as any subsequent increases will be based on the lower fee level and can never be recovered.
- Increases for out-of-province domestic students in alignment with government's fee policy.
- International fees remain unregulated.



Uncertain Environment for Budget Planning

- TMU is developing its 2023-24 budget in the context of an uncertain external environment:
 - Tuition fee framework for 2023-24 not yet announced
 - International recruitment in time of visa and travel issues
 - Inflationary pressures on fixed costs
 - Salary and benefits cost escalation
 - Bill 124 (public sector wage legislation) has been struck down
 - We are working through the implications on our budget

Operating Budget

- Reflects portion of overall budget that is within our discretion
- Consolidated budget includes items not within our discretion, e.g., research grants, special capital grants
- Toronto Metropolitan University's current operating budget is \$663.4 million
- Includes expenditures such as:
 - Academic departmental budgets
 - Student financial assistance
 - Infrastructure maintenance
 - Utilities
 - Other non-salary provisions

2023-24 Budget Model Assumptions

- Revenue projected to increase by 0.4%
 - No operating grant growth
 - Domestic tuition fee freeze
 - Modest international tuition fee increase within market rates
- Cost escalation projected to increase by 3.0%
 - Salary / benefit increases
 - Teaching costs
 - International recruitment costs
 - Deferred maintenance increase
 - Inflation on non-salary costs
- Total shortfall at least \$16.9 M
- We are requesting all budget managers to create plans to reduce base expenditures by 3.5%
